**Explanation of Responses:**

- The Chachagua Family Partnership (the "Partnership") distributed its holdings of 189,228 shares of the Issuer's common stock to its partners. Previously, the beneficial ownership of all of these shares had been indirectly attributed to Mr. Davidow. As a result of the distribution, the shares of the Issuer's common stock held indirectly by Mr. Davidow have decreased by 159,521 shares of common stock. The beneficial ownership of the 159,521 shares is no longer attributable to Mr. Davidow pursuant to the rules and regulations of the Securities Exchange Act of 1934, as amended.
- Includes shares that are subject to a lapsing right of repurchase at the initial purchase price of such shares in favor of the Issuer. These repurchase rights terminate according to a vesting schedule over a period of four (4) years, which ends on December 6, 2005.
