Settlement of vested Units into common stock will occur on the earlier of April 18, 2013 and the date the reporting person ceases to provide services to the Issuer, or thereafter, on the first market trading day in an open trading window under Issuer's insider trading policy if the applicable date is not a market trading day in an open trading window.
- If the reporting person ceases to provide services to the Issuer for any reason, all Restricted Stock Units that have not yet vested shall be forfeited without consideration except as provided in the "Equity Grant Policy for Outside Directors" and any other agreements between the reporting person and Issuer, regarding award vesting and exercisability.
